- Collaborated with a large probation agency to develop, pilot-test, and refine a needs assessment instrument currently used by over 200 probation officers.
- Develops and delivers in-person and virtual trainings and presentations on criminal-legal and health topics to researchers, practitioners, and policymakers.
- Directs a learning initiative that integrates eLearning with coaching for probation professionals and treatment providers, with the objective of increasing knowledge and use of evidence-based practices in criminal-legal system supervision.
- Develops and revises manuscripts for peer-reviewed journals and other written materials on study findings and policy implications.

- Presents study findings at research, policy, and practitioner conferences, including the College on Problems of Drug Dependency, the American Society of Criminology annual meeting, the American Probation and Parole Association Annual Learning Institute, the Addiction Health Services Research Conference, and others.
